## A Message from the South Dakota Synod Bishop



Dear South Dakota Synod,

Grace and peace to you in the name of our Triune God!

On behalf of your close to 200 partners across the South Dakota Synod I come to you to say thank you. Thank you for your generosity! Your benevolence to the ministry of the South Dakota Synod doesn't just keep the lights on and pays salaries, but mainly supports ministry on the ground. Please take a look at the "2023 South Dakota Synod Ministry Celebrations" insert included in this annual report. You will notice that YOU showed up in many and various spaces. Sometimes your presence was felt close to home through a grant you may have received or a synod staff that came to visit. At other times your presence impacted ministry in other parts of the world, such as our companion partners in the Lutheran churches in Nicaragua and Cameroon. Thank you also for your generosity above and beyond your benevolence. Our partners in Cameroon appreciated the synod's \$52,000 gift to support putting roofs on churches. The generosity of the congregations in the synod never ceases to amaze me, and I give thanks for your continued generosity as we journey together in Christ!



While many places celebrated an abundant year of ministry, I also want to acknowledge that for other ministry sites 2023 has not been as hoped for. Our mission statement commits us to "Journeying Together in Christ" and is based on Luke 24:13-34. Two disciples are on the road post resurrection and ponder in disbelief all the things that have happened before their eyes. They were overwhelmed and didn't know what to make of it all. I have heard from many ministry sites a similar account about 2023. "Bishop, things in 2023 were not as we had expected and hoped for. What do we do now?" In Luke's story Jesus, unrecognized by them, joins them and walks alongside to listen and remind them of the promises in scripture. But it isn't until they sit down at the table, and Jesus breaks bread that their eyes are opened. They recognize who he is and that the 'holy heartburn' they had experienced along the way was a sign that their love for Jesus and the way he calls them to live has changed them forever.

How about your community of faith? Where do you hear the promises of scripture assure you that God's got a plan for you and your ministry? Where are you called to follow the 'holy heartburn' God's Spirit ignites in you as you are fed at the table of love? I pray that your annual meeting will be an experience where you can voice what you had wished for as well as lament the unmaterialized hopes. And at the same time, you can hear where God promises new life and renewed faith in your very own midst.

Your South Dakota Synod staff and partners across the church are committed to accompany you in your ministry ventures, whether it means to take small courageous steps or giant leaps of faith. We are here to journey with you in Christ. Therefore, it is with great joy and delight that I am announcing to you that we, the South Dakota Synod, are a recipient of a \$1,137,384 grant Endowment Inc. through its Thriving Congregations Initiative. The STAR (Small Town and Rural) Table also offers two types of grants, which are only possible

through the generosity of the people and congregations of the SD Synod when we gather for rural ministry fundraisers. Again, details about the grant opportunities, and how you can apply for a grant are found on the synod's website <a href="https://www.sdsynod.org">www.sdsynod.org</a>.

Last but not least, I would like to invite you to the 2024 Synod Assembly on May 31st and June 1st at Our Savior's in Sioux Falls, SD. We will gather under the theme of "(Re)Connect." It will be a celebration of the partnerships we share across the synod and the wider ELCA. Stay tuned for more information about the business coming before the assembly and the fun opportunities. # 2023 MINISTRY CELEBRATION



Our Synod's vision of Journeying Together in Christ has continued to focus our work. We invite you to take a few moments to review the list below which celebrates some of the ministry we shared together in 2023. **Journeying together in Christ as the South Dakota Synod, in 2023 we:** 

- Applied for and received a grant of \$1,137,384 from Lilly Endowment Inc. through its Thriving Congregations Initiative for new initiatives that are not included the Synod's Mission Plan. Please reach out to Synod Staff for more information!
- Completed explorations for two new potential church plants, with plans to start a worshiping community in Box Elder and Shepherd's Table in Sioux Falls.
- Walked with the 40 people in various stages of Candidacy and have 4 new entrance interviews scheduled in 2024!
- Received 3 new first call candidates.
- Completed 23 Ministry Site Studies and extended 28 calls!
- Ensured that nearly every congregation has a called pastor, interim pastor, Synod Authorized Minister, or lay leader to care for God's people (thank you to all of you who are helping out with area congregations and filling in!).
- Distributed \$77,137 to date through the Seminary Debt Reduction Program.
- Granted **\$123,000** in scholarship funds to seminary students, **\$11,400** in internship site assistance, and **\$82,990** to Luther and Wartburg Seminaries, for a total of **\$217,390** in support of seminary education.
- Created a pilot rural J-term program with Wartburg Theological Seminary, which will begin in January 2024.
- Received \$113,635 in grants from ELCA Christian Community & Leadership.
- Held a Synod Assembly, where we gathered again as a community to conduct the business of the synod.
- Hosted Spring and Fall Theological Conferences, where we continued to support the continuing education of our Rostered Ministers either online or in-person.
- Supported the congregations and ministries of the synod through **visits** by synod staff, both **digital** and in-person.
- Hosted a "Lay Leader Night" to support congregational lay leaders and supported rostered leaders with regular inperson and virtual meetings, such as monthly rostered minister virtual check-ins, Synodically Authorized Minister, Senior Pastor, and Interim Pastor check-ins, and a First Call and Senior Pastor Retreat.
- Pr. Alan Blankenfeld, Synod **Rural Ministry Liaison** continued to journey with our rural ministry sites. In the past year, Pr. Alan has worked directly with **34 communities and congregations in transition**.
- Continued the work of the Rural Ministry Table, which is currently working on **Small Town and Rural (STAR) grants**, grants funded by the generous donations to rural ministry in the Synod.
- Partnered with Bergen Lutheran to hold a Threshing Bee which resulted in gifts of \$51,324 to support rural ministry in South Dakota.

Thank you for all the ways you have supported the ministry of the South Dakota Synod this past year! God has called us to be the body of Christ together, and this is an active and healthy body. We look forward to continuing our journey with you in 2024 and beyond!

# **Journeying Together in Christ**



#### An Introduction to the Journeying Together in Christ Grant from Lilly Endowment

As we announced earlier this month, the South Dakota Synod of the Evangelical Lutheran Church in America (ELCA) has been awarded a grant of over \$1.1 million from Lilly Endowment Inc. through its Thriving Congregations Initiative.

The grant will be used by the Synod to live fully its vision of "Journeying Together in Christ," by relating to congregations with intentionality, equipping leaders for ministry, networking across the church, and advocating for shared leadership, especially among our rural congregations.

The Synod developed the work of this initiative in response to three critical questions posed by Bishop Constanze Hagmaier and her staff in 2019 at statewide "Listen, Learn and Care" events: "What gives you joy?" and "What keeps you up at night?" and "How will we journey together?" One person's poignant response resonated deeply: South Dakota ELCA churches are struggling with "fitting who we are into pews made for who we were."

This grant will be used in two focus areas. First, it will be used to engage both lay and rostered congregational leaders by leveraging digital technologies to create *Connect*, a Synod-wide community hub for learning, resources and conversation. Next, it will be used to engage congregations with innovative Rural Immersion Ministries which will create congregational learning experiences designed to recognize and bridge the rural/urban cultural divide.

These projects are being funded through Lilly Endowment's Thriving Congregations Initiative. The aim of the initiative is to encourage the flourishing of congregations by helping them deepen their relationships with God, enhance their connections with each other, and contribute to the vitality of their communities and the world.

The work of this grant award will be closely aligned with the Synod's existing and emerging resources, expertise, and experience. However, it is important to note that this grant is funding work outside of the 2024 Mission Plan approved by the 2023 Synod Assembly. Therefore, it is critical that congregations and organizations continue their mission support to the South Dakota Synod to ensure that the regular and essential work of the Synod continues.

If you would like to find out more about the work that the grant award will enable, there will be two virtual informational meetings on **Tuesday**, **January 9**, **2024** that will be open to all members of the South Dakota Synod to attend - one at **12:30pm CT** and one at **7:30pm CT**. Both sessions will include time for attendees to ask questions about the grant. More information on how to attend these meetings will be provided in the Synod's weekly e-newsletter and the Synod website (www.sdsynod.org).

## **OSLC 2022 Annual Meeting Minutes**

January 29, 2023

With 50 members present and 4 attending via Zoom, President Diana Larson called the 2022 Annual Meeting to order at 10:05. Pastor Ramona Hayes led the congregation in an opening prayer.

Opening remarks by President Larson included the overwhelming amount of service the congregation has given through the year, and how appreciated this is.

Approval of 2022 annual meeting minutes from January 30, 2021: Motion by Larry Wilske, second by Becky Sayler, all in favor.

Approval of 2023 Annual Meeting agenda made by Todd Sanderson, seconded by Jenn Headrick, all in favor.

#### 2022 Treasurer's report

- Discussion/Clarification on Chicken Supper Expenses
- Total giving down for 2022

Motion to approve report by Larry Wilske, seconded by Sandy Harris. All in favor.

**Committee Report** highlights included the completion of over \$50,000 in capital improvements; the involvement of over fifteen groups that volunteered when needed; the support of community groups and Synod projects with financial support of over \$36,000; along with an increase in youth group participants and interactions between youth and the congregation.

#### **New Business**

- Constitution updates will include changes to OSLC constitution to mimic the Synod Constitution.
- OSLC By-laws will need to be updated, and President Larson will give updates as this occurs.

#### 2023 OSLC Proposed Budget

Diana reviewed the 2023 budget highlighting the following: changes to insurance provided to Pastor and husband, Tim; capital outlay expenses of new windows in education unit and parsonage updates;

It was recommended that a line item be added to pay Video/Live streaming Specialists(2) \$20/week. Adding \$2600 to the recommended budget.

Diana pointed out that the passage of this budget would equate to an approximate donation of \$1000 a year per family. Motion to approve 2023 budget by Larry Wilske, seconded by Roger Ehlers. All in favor.

Jeremy Haugen voiced appreciation for the generous financial support to his education.

Motion to adjourn at 10: 49 by Allison Ramsdell Unger, Seconded by Sandy Harris, all in Favor. Meeting closed with the Lord's Prayer.


# Pastor's Letter

# **COMMITTEE REPORTS**

# **Education Committee**

"Do everything for God- Especially the small things" Colossians 3:17

The Education committee is excited with all the great things happening at OSLC in 2023.

#### **Sunday School Update:**

In 2023, Jaycie Pulscher stepped up to be our Sunday School superintendent. She has done a magnificent iob in this role; she truly blesses us. In addition, we have been blessed with wonderful teachers and Prayer Partners to teach our children about the Lord. There are approximately 45 children in preK-4th grade who attend OSLC Sunday School on Sunday AM at 10:15. We kicked off the year by coming up with an incentive theme to encourage attendance. This was a lot of fun for the children as they participated in R.A.C.E (remembering and celebrating everyone) to finish their Sunday school year with an ice cream party. We celebrated Easter with a Sunday School "Egg" stravaganza. In April, the 4th graders received their bibles. May brought a wonderful Recognition Sunday and celebrated a successful Sunday School year. Each student received an OSLC customized cup, candy, and bible verse. In the summer, many of our students attended community VBS hosted at OSLC. 11 students went to Lutheran Outdoors Bible camp and returned with so much excitement we look for this number to grow in 2024. In August, we had a swim-up sign-up for the Sunday school year of '23-24 at the Flandreau Aquatic Center. Rally Sunday in September kicked off the new Sunday School year with a "Dream Small" theme. Every student has been encouraged to do small acts to make a difference in our Church, Community, and their families. Each week, we focused on a bible verse about the small things. OSLC students continued to sing on the first Sunday of every month during Church. Another addition was JAM (Jesus and Me). This is led by OSLC Youth Group and attended by K-4th grade 1 time a month on Wednesday evening. This fall was busy with Bibles to 3rd Grade, 1st Communion, including a dedicated evening of prepping for our 4th and 5th grade, Camp Sunday, and a special activity for Reformation Sunday. In December, the Christmas story was reenacted for our Christmas program and included all the youth at OSLC. That evening, a Live Nativity was displayed in our parking lot for all to take in. All students received a prayer blanket as a Christmas present made and donated by OSLC quilting group.

#### **Pre-Confirmation and Confirmation:**

We have 9 fifth grade students and 8 sixth grade students in preconfirmation. The fifth-grade students are learning Christian Character Values, while the sixth grade is studying the Old Testament. The confirmation class has 6 seventh grade students and 5 eighth grade students. This year is the "Living a Life of Faith" year, a discussion of how faith and everyday life intersect. Both groups participated in God's Work, Our Hands Sunday and worshipped at Church on the Street, serving the meal after worship. We have an ongoing service project: collecting quarters for Laundry with Love. The 6-8th grade led our Christ the King Sunday worship, and 7th-8th grade lead midweek services for Lent and Advent. We look forward to continuing learning to serve by acolyting and helping with church ministries, as well as service work in the community.

#### **Youth Group**

We had another blessed year with the youth. There were 25 kids registered for YG, and averaged 18-22 youth for Wednesday night YG. Their Wednesday youth group nights consisted of supper, group prayer with conversation, and followed by team building game.

They continued to host the 1st Sunday of the month breakfast for the congregation. They made many prayer blankets for the shut ins and gave them as gifts for Bingo prizes, did their Christmas caroling and played bells for the Christmas program. In May we had the largest group of kids graduate from OSLC but, it also was the largest group to be baptized. In August they hosted the 1st annual" Praise God Softball Tournament". They had 5 teams, ages YG to congregation. The Alumni YG was the winner of the tournament. There were many laughs, sore muscles and memories made. Supper was followed in the Japanese Garden shelter.

This fall they started J.A.M. (Jesus and Me) with the Sunday school kids. This is hosted on the 1st Wednesday of each month. They are averaging 27 kids per time. The youth are having a great time leading, and the Sunday School kids love being with the Youth.

There are 3 YG girls, Layla Latterell, Sadie lott, and Olivia Peters that will be heading to New Orleans in July 2024 for Youth Gathering.

The Youth also did a few fundraisers, Sioux Valley Energy and Legion Post #6 in Pipestone. This helped with the outings they enjoyed as a group. They did bowling, golf, and a corn maze.

2023 was a blessed year with the Youth Group. They are always willing to step in and help and lead when asked.

# **Bethel Lutheran Home**

(Complete report available in Fellowship Hall & on Ed. Unit Bulletin Board)

Since Bethel Lutheran Home opened its doors on March 25, 1962, we have had the amazing opportunity to serve thousands of residents as an extension of your Church. You continue to bless us with good people, both by electing excellent delegates and by referring friends and family who need our services. We are so grateful for all that you do for Bethel Community!

Our 62<sup>nd</sup> annual corporation meeting is scheduled to be held on January 22, 2024, at Trinity Lutheran Church, to review the fiscal year end 2023 audited financial statement for Bethel Lutheran Home, Inc. January will now become our new Annual Meeting date due to the complexity of our audit as well as the time it takes Casey Peterson to complete the required documentation.

I want to take a few moments to thank everyone for their renewed service to Bethel and our mission in Lake County. Your generous gifts, both monetary and valuable time, have made a dramatic improvement in the lives of the Residents, staff, and our "Community." Every one of you has profoundly impacted our lives and I truly want to say "Thank You" from the Bethel Community.

#### Staffing Impact at Bethel

Staffing remains the one of our largest challenges ending 2023 and entering 2024. Locating, hiring, and maintaining normal staffing has remained a challenge. However, by the end of 2023 we have seen a dramatic increase in applications as well as new hires which has led to a reduction in Agency staffing needs. We have had 5-6 open CNA positions since March 2021 which we have filled 50% of these openings the end of 2023 alone. CMS requires nursing facilities to maintain specific staffing levels. If the facility misses this benchmark, CMS can impose monetary penalties. To combat this, we utilize Agency staffing to fill open positions to maintain a census and provide quality care. The problem this presents is we must pay temporary staffing companies approximately 50% more than we are able to pay our full-time and part-time staff.

Decreased staffing numbers also affect the number of residents that we can effectively provide care for. Currently our census is on average 54 residents or 91% occupancy. It is important that the quality of care should not be compromised to keep Bethel full. We will increase census as staffing allows. Bethel is among the top 10% of Long -Term Care facilities in South Dakota based on census, most facilities at this time average a 75%-85% occupancy.

#### **Operational Updates**

Bethel's revenue had a small decrease in revenue \$6,232,669.59 compared to \$6,632,460 in 2022. Our Profitability, Activity and Efficiency (Return on Capital Employed) ratios have all decreased due to our Agency staffing as well as current inflation rates. Of note, thanks to our South Dakota Legislature our profitability has increased in July 2023 due to the passing of the Medicaid Increase to 100% methodology. Working capital or the time to collect payments was 13.63 days in 2022 currently we are at 13.00 days in 2023.

#### **Capital Improvements**

The roof over the Bethel Home needs to be replaced as was stated in the 2021 report with a cost of approximately \$300K. Bethel applied for a grant to replace the existing HVAC system with an upgraded filtration system that will be compliant with new air quality standards and was awarded \$251,912. The contract was awarded to Barger Electric with the project beginning September 2022 and this project ended in September 2023. Bethel now has a new HVAC system as well as each room now has its own "fresh air" return. We have added (4) reverse flow isolation rooms for respiratory illnesses if needed.

#### **Technology Improvements**

In 2023 we did not improve any technology assets as Bethel was in a good position. In 2023 we dramatically improve our Cyber Security posture through a grant received by DSU to assess and mitigate Cybersecurity concerns. Thanks to a grant through DSU we implemented a new VPN, Multi-Factor Authentication software among many other safeguards to ensure our resident information is secure. This grant will allow for our system to be actively scanned and defended by local vendors in Madison as well as the State of South Dakota. These services will be paid for in the year 2023 and potentially going forward depending on continued Federal Grant Funding.

We installed a new PA system to allow for facility wide communication as our old system is no longer functioning and not able to be repaired.

We upgraded our Camera Security system by purchasing a new server as well as a new camera by the employee entrance. This system was over 10 years old and not able to be upgraded due to age.

#### **Additional Updates for FY 2023:**

Thanks to a very strong push in this legislative session a 24% increase and rebase for Nursing Home Medicaid reimbursement passed which equates to a 100% reimbursement based on the current model. The new reimbursement will help alleviate some of the financial burden while potentially helping with recruitment and infrastructure needs.

#### Overview of challenges facing Bethel

CNA turnover rates and competition with staff agencies. Currently we pay a single Agency CNA at a significantly higher rate than our "organic" staff. This is a non-sustainable model; we are in drastic need for CNAs in Long-Term Care.

Capital improvements – Bethel is getting older, and several updates are needed.
